
ROADSIDE MOWING - 2026

Street Termini & Length: This estimate is for one cycle of mowing by the Ottawa County Road Commission and one cycle of string trimming on the portions of MDOT State Trunkline US-31 and BL-196 within the limits of Holland Charter Township in Ottawa County.

Special Conditions and Remarks: This estimate is for mowing to be performed in addition to one routine mowing cycle anticipated to be performed in June. String trimming is not included in routine mowing. Additional mowing and or string trimming will be performed only upon approval of this estimate and upon request of an authorized representative of Holland Charter Township. Mowing is to include machine mowing of the entire median, a 12' wide swath adjacent to the shoulder on each side of the highway/ramp and clear vision areas. String trimming is to include trimming around all posts and/or obstacles in the mowed areas.


CHLORIDE PROGRAM - 2026
