Regular Meeting August 21, 2025

The Supervisor called the meeting to order at 7:00 p.m.

Present: Supervisor Russ TeSlaa, Clerk Michael Dalman, Treasurer Vince Bush, and

The Pledge of Allegiance was recited and Mr. Bulthuis gave the invocation.

Mr. TeSlaa reviewed the consent agenda.

A motion was made by Mr. Nienhuis, supported by Mr. Bush, to approve the consent agenda including communications, operational reports (Sheriff's Department Activity Report for July), and the minutes of the Board meeting held on August 7, 2025.

The first agenda item was a presentation on the 2025 Housing Analysis by Christopher Khorey from McKenna Associates. Following the presentation Planning Commission chairperson Randy Kortering addressed the Board and said the Planning Commission approved the study. He then stated that the Planning Commission was focusing on owner occupied dwellings and asked for further input from the Board.
